Joint standards on Returnable Packaging supplied by Vetropack

Vetropack accepts its share of responsibility for natural wear and tear effects on returnable pallets and layers. However, we must limit the level of acceptance for both scrap and repair to the agreed targets made with your sales representative.

Before loading of the packaging material for return to Vetropack at customer's site an appropriate sorting and final check shall be made by the customer to make sure that the requirements outlined in this document are met.

Before unloading at our site a first visual check shall be carried out by Vetropack's authourised representative. If at first glance the check has been successfully passed the item level check and sorting shall be carried out within a reasonable time period after unloading. For this item level sorting the current criteria for quality acceptance shall be strictly applied. Anything exceeding the agreed share or indeed wrongly returned material in terms of dimensions, characteristics or quantities cannot be accepted by Vetropack and will either be disposed of or returned, both actions are chargeable to the Customer. Vetropack will document and label those quantities appropriately and send the completed official claim documentation to the customer within a reasonable time-period.
